### **New Business**

Suzie gave a report on a radio show about defensible space. Host, Mike Kelly and guest, Eric ?? had a thorough discussion on the topic and gave a "plug" to Fire Safe Sonoma. Marj reported on some of the activities and plans the Soroptomist's have for the Fire Trailer. Bags are being assembled to hand out to children that contain coloring books, and crayons. There will be a "Stuff" party after the Rose Parade. 50 Dalmatian stuffed animals were purchased to decorate trailer and will be given to children in the Children's Burn Center. Suzie asked who would be responsible for the education end? Marj would follow up with Jack to be sure that fire professionals/trainees take care of the education aspect as Soroptomists are not qualified.

Tamara reported that during her phone conversation (earlier in the meeting) with Jack, that he had requested that the FSS Board give permission to have Carleon draft a press release spinning off of the Board of Supervisor's resolution which was approved on the Tuesday prior to the meeting.
