THE EVENT IS DESIGNED TO SUPPORT COMMUNITY MEMBERS IN EFFORTS TO **REDUCE FIRE FUEL TO MAKE THEIR** PROPERTIES AND COMMUNITIES SAFER IN THE FACE OF WILDFIRES. WE WILL DISCUSS LIVESTOCK GRAZING AS A VEGETATION MANAGEMENT TOOL, THE ADVANTAGES OF COLLABORATING WITH YOUR NEIGHBORS ON A PROJECT, WE WILL LEARN ABOUT LOCAL FIRE RESILIENCY EFFORTS, AND WE WILL SHARE OTHER **RESOURCES AVAILABLE TO THE PUBLIC.** WE WILL HAVE A PANEL OF SPEAKERS THAT INCLUDE FIRE AND RCD **REPRESENTATIVES, LIVESTOCK AND** PRESCRIBED GRAZING PROFESSIONALS, AND REPRESENTATIVES FROM THE LOCAL FIRE SAFE GROUPS.

In October 2020, following extensive community and stakeholder outreach, the Sonoma County Board of Supervisors voted to allocate a minimum of \$25 million of PG&E settlement funds toward diverse vegetation management activities to reduce wildfire risk, promote safety, and support ecosystems and agriculture, along with associated governance, education, funding/ financing, and workforce development efforts.

GRAZING IS ALSO THE MORE CARBON BENEFI-CIAL CHOICE FOR FUEL REDUCTION IN AREAS WHERE PRESCRIBED BURNS ARE INADVISABLE OR IN SENSITIVE ECO-LOGICAL AREAS WHERE THE APPLICATION OF HERBICIDES IS NOT AP-

COMMUNITY RESILIENCE TO WILDFIRE RE-QUIRES AN INTENTIONAL SHIFT TOWARD COM-MUNITY ADAPTATION GIVEN THE INEVITABIL-ITY OF WILDFIRES, INSUFFICIENT RESOURCES, AND NEED TO PROTECT THE ENVIRONMENT. TARGETED GRAZING OR PRESCRIBED HER-**BIVORY IS ALSO USED FOR VEGETATION MAN-**AGEMENT AND IS BENEFICIAL FOR AIR QUALITY, NOISE, PROXIMITY TO STRUCTURES, STEEP SLOPES, AND AREAS WITH NOXIOUS WEEDS. GRAZING CAN ALSO BE THE MOST FINANCIALLY ACCESSIBLE AND EASIEST TO IMPLEMENT DUE TO LACK OF PERMIT REQUIREMENTS COM-PARED TO OTHER FUEL TREATMENTS SUCH AS HAND CREWS, MOWING, MASTICATING OR PRE-SCRIBED BURNS.
