A) Project: Defensible Space

Priority: H

Category/s: Ignition Reduction, Fuels Reduction

Goal: Minimize structural ignition and damage from wildfire (from radiant heat, embers, and direct flame impingement) by reducing/removing vegetation adjacent to structures.

- Conduct an education/awareness campaign via community presentations, site visits, and inspections/assessments to educate on defensible space and fuels reduction.
- Provide training for community members to perform assessments for their neighbors
- Seek funding for contractors to create defensible space and funding for residents and/or property owners who may need financial assistance. Establish criteria for providing funding.
- Develop plan for periodic inspections

Participants: Licensed contractors, FireSafe Sonoma, CAL FIRE, Healdsburg Fire Department, North Bay Fire, Permit Sonoma, property owners, PG&E.

Timing: Year-round assessment/inspections by request. Inspections scheduled for spring through early fall. Associated vegetation management activities by individual property owners can occur year-round.

B) Project: Early Warning Communication Protocols

Priority: H

Category/s: Emergency Notification and Communication **Goal:** Ensure earliest possible warning during emergencies

- Develop and communicate community and neighborhood wide notification procedures and plans during emergencies
- Include investigating and/or distributing; Phone trees, car horns, text, email, OneCall Now, NOAA Radios other technologies (such as placement of a fire camera in the Mill Cree Area, additional cell tower with battery back-up, etc)
- Develop informal neighbor notifying neighbor recommendations

C) Project: Educate Community on Fuel Reduction Programs and Options

Priority: H

Category/s: Fuels Reduction

Goal: Increase awareness of land management for wildfire fuels reduction

- Engage with existing fuels and timber management programs to reduce potential fuel
- Educate local landowners about CVTP Vegetation Thinning Grants

- Coordinate local workshops on developing Forest Management Plans and THPs, etc. Explore opportunities to restore old-growth characteristics to benefit fish, water quality and birds, and reduce erosion by fuel/veg removal. "Fuel thinning may also improve or maintain the quality of in-stream aquatic habitat for endangered Coho and steelhead. Managing redwood forests to restore fire-resilient old-growth characteristics can also enhance water quality, streambed rehabilitation, and sensitive species in the riparian/redwood ecosystem.
- Bring together officials and groups of residents who may be interested in engaging in these projects

D) Project: Fire & Emergency Preparedness Awareness

Priority: H

Category/s: Access and Evacuation

Goal: Provide community safety training on communication, evacuation, and emergency planning to minimize confusion and ensure efficient response during an emergency

• Include Topics: Emergency "To-do" lists, Go-Bags, Shelter-in-Place Tips, CERT, Special Evac Needs, Animals, Knox box and gate protocols, evacuation signage and annual evacuation drill.

E) Project: Vegetation Management Along Primary and Secondary Roads

Priority: M

Category/s: Access & Evacuation, Fuels Reduction

Goal: Reduce/remove hazardous vegetation along primary and secondary roads to support ingress and egress of residents evacuating, emergency vehicles, and reduce wildfire intensity.

- Mill Creek Road is a county maintained road and the only primary road that serves the Mill Creek Area. Secondary roads are mostly privately maintained and are Mill Creek Lane Wallace Creek Road, Puccioni Road, and Palmer Creek Road
- Identify critical areas and prioritize. Includes: Trimming overhanging branches, chipping all cut and dead material, removing (cut, pull and/or spray) understory shrubs and pruning and/or selective removal of trees or tree branches that; A) pose a risk of falling on powerlines (Ignition); B) trees that may fall on the road and block access (Access & Evac); and C) lower level fuels (dead and alive) that are fuel for fire (Fuel Reduction).
- Identify funding and potential resources to implement work
- Include execution plan and align with available chipper programs
- Sonoma County Transportation and Public Works(TPW) has responsibility to keep the roadway clear of vegetation within their right of way. This distance is usually 5-10 feet

from the edge of Mill Creek Road and the TPW maintained portion of Wallace Creek Road. Beyond the right of way, the responsibility becomes the individual property owner. Environmental review will be required outside of the TPW right of way if government funding will be used for this project.

F) Project: Home Hardening

Priority: M

Category/s: Ignition Reduction, Fuels Reduction

Goal: Minimize structural ignition and damage from wildfire (from radiant heat, embers, and direct flame impingement) by retrofitting existing structures

- Conduct an education/awareness campaign via community presentations, site visits, and inspections/assessments
- Seek funding for contractors to create defensible space and funding for residents and/or property owners who may need financial assistance. Establish criteria for providing funding.

G) Project: Uniform, Reflective Address Sign Program

Priority: M

Category/s: Access and Evacuation

Goal: Ensure first responders can locate emergencies and structures to defend from a wildfire, by having address signs meet Sonoma County ordinance requirements

- Order and fund payment of signs
- Organize a volunteer day for sign installation

H) Project: Neighborhood and Community Mapping

Priority: M

Category/s: Access and Evacuation

Goal: Provide accurate, useful and updated maps to facilitate firefighting and evacuation efforts during emergencies

- Assume the majority of first responders will not be familiar with the Mill Creek Area
- Complete and update Neighborhood and Community Maps, designed for the initial phases of a rapidly developing, dynamic wildfire situation
- Identify neighborhood meeting points, landing zones, water supply locations
- Explore developing property maps to include better detail on location of water tanks, pools, standpipes etc.
- Include identifying funds/cooperation to better develop fire roads or pre-attack lines (ridgetops, etc)

Timing: Year-round with annual update deadline prior to peak fire season conditions and/or July 1

- Install signs where feasible
- Develop usage protocols and best practices
- Inform residents of the Mill Creek Area and conduct annual drills.

- Phase project to include:
- Identify appropriate/effective locations
- Fund/conduct preburn studies needed for permits
- Conduct any preburn clearing/prep
- Fund and implement prescribed burn
- Carry out follow-up management/planting

- Assist in advising/funding of developing additional water sources
- Develop water storage projects that allow for the collection of water during the wet winter months to 1) offset dry-season water use to assist in Mill Creek streamflow improvement efforts for oversummer salmonid survival and 2) increase water security and reliability in the fire-prone summer/fall months.
